ORDINANCE NO. 277

AN ORDINANCE TO ACCEPT THE DEDICATION TO PUBLIC USE AS A STREET OF A PORTION OF FAGAN ADDITION ADJOINING THE TOWN OF BERTHOUD, COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, COLORADO:

WHEREAS, by the Plat of Fagan Addition, being a portion of the South half of the Southeast quarter ($S\frac{1}{2}-SE\frac{1}{4}$ of Section fourteen (14), Township four (4) North, Range sixty-nine (69) West of the 6th P.M., Larimer County, Colorado, filed for record with the Clerk and Recorder of said County on February 26, 1953, in Plat Book 6, at Page 59, there was dedicated to public use as a street a portion of said Fagan Addition described on said Plat as "Dedicated to Capitol Avenue", and

WHEREAS, the Town of Berthoud has accepted said dedication by maintaining said described portion as a street and by designating it as part of Capitol Avenue, Town of Berthoud,

NOW, in order to make it a matter of public record that the said Town has accepted said dedication,

BE IT FURTHER ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, COLORADO:

Section 1. That the dedication to public use as a street of a portion of Fagan Addition, as hereinabove described, be, and it is hereby accepted by the Town of Berthoud, and the said portion is designated as a part of Capitol Avenue, Town of Berthoud.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, COLORADO:

WHEREAS, by the Plat of Fagan Addition, being a portion of the South half of the Southeast quarter ($S\frac{1}{2}-SE\frac{1}{4}$) of Section Fourteen (14), Township Four (4) North, Range Sixty-nine (69) West of the 6th P.M., Larimer County, Colorado, filed for record with the Clerk and Recorder of said County on February 26, 1953, in Plat Book 6, at Page 59, there was dedicated to public use as a street a portion of said Fagan Addition described on said Plat as "Dedicated to Capitol Avenue", and

WHEREAS, the Town of Berthoud has accepted said dedication by maintaining said described portion as a street and by designating it as part of Capitol Avenue, Town of Berthoud,

NOW, in order to make it a matter of public record that the said Town has accepted said dedication,

BE IT FURTHER ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, COLORADO:

Section 1. That the dedication to public use as a street of a portion of Fagan Addition, as hereinabove described, be, and it is hereby accepted by the Town of Berthoud, and the said portion is designated as a part of Capitol Avenue, Town of Berthoud.
