

AN ORDINANCE AUTHORIZING THE EXPENDITURE OF FUNDS IN EXCESS OF 1980 BUDGET.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, COLORADO:

FINDINGS:

Section 1. When the Board of Trustees of the Town of Berthoud established the budget for 1980, it allocated \$12,000.00 for the improvement of the waste water treatment plant and for identification and correction of infiltration. However, because of the extremely heavy snowfalls experienced in this area and the resulting increased infiltration, the waste water treatment plant is exceeding its hydraulic capacity. Additional expenditures are necessitated to allow the plant's hydraulic capacity to be increased and to control some of the infiltration.

These additional expenditures would necessitate exceeding the budget for Capital Improvements for the sewer department.

ALLOCATION:

Section 2. Under the provisions of Colorado Revised Statutes 1973, Local Government Budget Law of Colorado, the Board of Trustees of the Town of Berthoud hereby authorizes the expenditure of funds in excess of the 1980 budget in the amount of \$ 29,000.00. These funds shall be expended for the improvements set forth hereafter:

1. Conversion of Digester.	\$ 20,000.00
2. Pump and clean old Digester.	4,000.00
3. Root removal in storm drain.	2,000.00
4. Identification & elimination of infiltration in municipal lines.	15,000.00
	Total \$ 41,000.00

Wherefore the Board of Trustees of the Town of Berthoud hereby authorizes the expenditure from the Sewer Depreciation Fund appropriated for the 1980 budget of \$ 29,000.00.

EMERGENCY:

Section 3. The Board of Trustees herewith determines and designates that this ordinance is necessary for the immediate preservation of the public health and safety; and whereas, in the opinion of the Board of Trustees the emergency condition exists at the waste water treatment plant, this ordinance shall take

effect and be in force immediately after its final passage and adoption and publication.

The above Ordinance was introduced, read, and passed on first reading and adopted by the Board of Trustees of the Town of Berthoud, Colorado, at its regular meeting held Tuesday, March 11, 1980, with five trustees voting for the adoption of this Ordinance.

The Town Clerk is hereby directed to send a certified copy of this Ordinance to be filed with the State Division of Local Government and publish one time in a newspaper having general circulation within the limits of the Town of Berthoud.
