

ORDINANCE NO. 664

AN ORDINANCE AUTHORIZING THE EXPENDITURES
OF FUNDS IN EXCESS OF THE 1991 BUDGET.

BE IT ORDAINED BY THE BOARD OF TRUSTEES FOR
THE TOWN OF BERTHOUD, COLORADO, LARIMER COUNTY,
COLORADO, THAT:

Section 1. WHEREAS, during 1991, the Town of Berthoud, determined that the Wastewater Fund did not allocate adequate funds for the additional operating cost due to a change in the sludge removal process; and

WHEREAS, the Board of Trustees, hereby designates \$33,773.00 of surplus, be applied to the additional operating cost due to sludge removal; and

Section 2. WHEREAS, in 1991, the Town of Berthoud, determined that the Cemetery Endowment Fund did not allocate adequate funds for salaries and maintenance; and

WHEREAS, the Board of Trustees, hereby designates \$7,325.00 of surplus, be applied to the cost of salaries and maintenance; and

Section 3. WHEREAS, in 1991, the Town of Berthoud, determined that the Conservation Trust Fund did not allocate adequate funds for the equipment and maintenance; and

WHEREAS, the Board of Trustees, hereby designates \$4,785.00 of surplus, be applied to the cost of equipment and maintenance; and

Section 4. WHEREAS, in 1991, the Town of Berthoud, determined that the Library Fund did not allocate adequate funds for salaries; and

WHEREAS, the Board of Trustees, hereby designates \$1,145.00 of surplus, be applied to the cost of salaries; and

Section 5. WHEREAS, in 1991, the Town of Berthoud, determined that the State Police Pension Fund did not allocate adequate funds for benefits; and

WHEREAS, the Board of Trustees, hereby designates \$12,447.00 of surplus, be applied to the cost of benefits; and

Section 6. WHEREAS, in 1991, the Town of Berthoud, determined that the Drainage Fund did not allocate adequate funds for engineering; and


WHEREAS, the Board of Trustees, hereby designates \$4,877 of surplus, be applied to the cost of engineering; and

WHEREAS, the Board of Trustees determines and designates that these expenditures could not have been accurately forecast at the time the Budget was drafted and that these expenditures were necessary for the immediate preservation of the public health and safety; and

WHEREAS, in the opinion of the Board of Trustees an emergency exists, which jeopardizes the fiscal welfare of the Town and would affect the health and safety of its citizens. This Ordinance shall take effect and be in force upon its final passage and adoption.


At the meeting held on December 10, 1991, the
