

ORDINANCE NO. 828

AN ORDINANCE ASSESSING THE COST OF IMPROVEMENTS TO STREETS LOCATED IN THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO.

WHEREAS, pursuant to §31-15-702(VIII)(b)(I) and (II), Colorado Revised Statutes, the Town of Berthoud has the following powers: "(I) To provide for the construction and maintenance of sidewalks, curbs, and gutters of such material and in such manner as shall be designated and to provide for paying the expenses thereof by special assessments upon the adjacent or abutting property, which assessments shall constitute a lien as provided in section 31-15-401(1)(d)(I); and (II) To grade, grade or gravel, or otherwise surface or improve streets and alleys and to assess the costs of such improvements upon the lots or lands adjacent to or abutting upon any street or alley or portion thereof so improved, which assessments shall constitute a lien as provided in section 31-15-401(1)(d)."'

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO:

Section 1. Assessment Lien

Assessments for the improvements to Turner Avenue, Capitol Avenue and Franklin Avenue, and all interest thereon and penalties for default in payment thereof and all costs in collecting the same shall be levied against the following properties which shall be collected by the Larimer County Treasurer. The Larimer County Assessor shall create separate schedules for each lot or tract of land assessed pursuant to this ordinance.
