ORDINANCE NO. 977

AN ORDINANCE REZONING CERTAIN REAL PROPERTY HERETOFORE ZONED M-1 (LIMITED INDUSTRIAL DISTRICT) BY THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO.

Section 1.

WHEREAS, pursuant to the Planning and Zoning Ordinances of the Town of Berthoud, the Board of Trustees determines that the hereinafter described area of the Town requires rezoning.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO:

Section 2.

The property described on Exhibit "A" attached hereto and incorporated herein by reference, being a portion of the Town of Berthoud, Larimer County, Colorado, is rezoned from M-1 (Limited Industrial District) to M-2 (Industrial District).

Section 3. Effective Date:

The Board of Trustees of the Town of Berthoud herewith finds, determines and designates that this Ordinance shall take effect and be in force 30 days after publication.

At its meeting October 28, 2003, a public hearing was set by the Board of Trustees of the Town of Berthoud for its meeting held on the 18th day of November, 2003. After the public hearing, this Ordinance was read, passed and ordered published by the Board of Trustees at its meeting this 18th day of November, 2003.
