

ORDINANCE NO. 1074

AN ORDINANCE REPEALING ORDINANCE NUMBERS 1046 AND 1052 OF THE MUNICIPAL CODE OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO:

Section 1. Monthly minimum Water Fees:

The monthly minimum water fees shall be increased 15% as follows and Ordinance Numbers 1046 and 1052 are hereby repealed.

Section 2. Monthly Water Volume Charges:

The monthly water rates for Multi-Family, Educational, Commercial and Residential usage shall be increased from the rates established in Ordinance Numbers 1046 and 1052 by 15% as follows:

5/8 & 3/4 Inch Tap - (Rate Table 121)

First 24,000 gallons @ \$3.50 per thousand

Over 24,000 gallons, \$6.99 per thousand

1-Inch Tap – (Rate Table 122)

First 60,000 gallons @ \$3.50 per thousand

Over 60,000 gallons, \$6.99 per thousand.

1-1/2 Inch Tap – (Rate Table 123)

First 120,000 gallons @ \$3.50 per thousand

Over 120,000 gallons, \$6.99 per thousand

2-Inch Tap – (Rate Table 124)

First 192,000 gallons @ \$3.50 per thousand

Over 192,000 gallons, \$6.99 per thousand

4-Inch Tap – (Rate Table 126)

First 600,000 gallons @ \$3.50 per thousand  
Over 600,000 gallons, \$6.99 per thousand.

6-Inch Tap – (Rate Table 127)

First 1,200,000 gallons @ \$3.50 per thousand.  
Over 1,200,000 gallons @ \$6.99 per thousand.

**EDUCATIONAL USAGE**

(Rate Tables 151, 154, 155 and 156)

First 192,000 Gallons, Base rate @ \$3.70 per thousand.  
Over 192,000 gallons @ \$7.41 per thousand.

First 24,000 gallons @ \$3.25 per thousand  
Over 24,000 gallons @ \$6.51 per thousand

All usage \$3.25 per thousand

Over 24,000 gallons @ \$9.80 per thousand

1-Inch Tap – (Rate Table 162)

All usage @ \$4.90 per thousand

### **RESIDENTIAL USAGE INSIDE TOWN**

5/8 & 3/4 Inch Tap – (Rate Table 101)

First 24,000 gallons @ \$4.05 per thousand

Over 24,000 gallons @ \$8.10 per thousand

1-Inch Tap – (Rate Table 102)

First 60,000 gallons @ \$4.05 per thousand

Over 60,000 gallons @ \$8.10 per thousand

2-Inch Tap – (Rate Table 104)

First 192,000 gallons @ \$4.05 per thousand.

Over 192,000 gallons @ \$8.10 per thousand.

### **RESIDENTIAL USAGE OUTSIDE TOWN**

5/8 & 3/4 Inch Tap – (Rate Table 111)

First 24,000 gallons @ \$6.06 per thousand

Over 24,000 gallons @ \$12.12 per thousand

1-inch Tap – (Rate Table 112)

First 60,000 gallons @ \$6.06 per thousand

Over 60,000 gallons @ \$12.12 per thousand

### **Section 3. Wastewater Fees:**

The following fees shall be charged for wastewater service. The prior wastewater fee is hereby increased 18%:

Monthly Service Charge

\$25.75

Monthly Fee Per 1,000 Gallons

\$6.21

Section 4 Effective Date:

The fees set forth in this ordinance shall take effective with the January, 2008 billing cycle.

At its meeting October 23, 2007, a public hearing was set by the Board of Trustees of the Town of Berthoud for its meeting held on the 13<sup>th</sup> day of November, 2007. At the regular meeting of the Board of Trustees, this Ordinance was read, passed and ordered published this 13th day of November, 2007.
