

ORDINANCE NO. 1046

AN ORDINANCE REPEALING ORDINANCE NUMBER 1019 OF THE MUNICIPAL CODE OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO:

Section 1. Monthly minimum Water Fees:

The monthly minimum water fees shall be increased 15% as follows and Ordinance Number 1019 is hereby repealed.

Section 2. Monthly Water Volume Charges:

The monthly water rates for Multi-Family, Educational, Commercial and Residential usage shall be increased from the rates established in Ordinance Number 1019 by 15% as follows:

Over 24,000 gallons, \$6.08 per thousand

Over 60,000 gallons, \$6.08 per thousand.

1-1/2 Inch Tap – (Rate Table 123)

First 120,000 gallons @ \$3.04 per thousand

Over 120,000 gallons, \$6.08 per thousand

2-Inch Tap – (Rate Table 124)

First 192,000 gallons @ \$3.04 per thousand

Over 192,000 gallons, \$6.08 per thousand

4-Inch Tap – (Rate Table 126)

First 600,000 gallons @ \$3.04 per thousand

Over 600,000 gallons, \$6.08 per thousand.

6-Inch Tap – (Rate Table 127)

First 1,200,000 gallons @ \$3.04 per thousand.

Over 1,200,000 gallons, \$6.08 per thousand.

First 60,000 gallons @ \$3.52

Over 60,000 gallons @ \$7.04 per thousand

2-Inch Tap – (Rate Table 104)

First 192,000 gallons @ \$3.52 per thousand.

Over 192,000 gallons @ \$7.04 per thousand.

**RESIDENTIAL USAGE OUTSIDE TOWN**

5/8 & 3/4 Inch Tap – (Rate Table 111)

First 24,000 gallons @ \$5.27

Over 24,000 gallons @ \$10.54 per thousand

**Section 3. Wastewater Fees:**

The following fees shall be charged for wastewater service. The prior wastewater fee is hereby increased 18%:



Section 4 Effective Date:

The Board of Trustees of the Town of Berthoud herewith finds that the adoption of this ordinance is necessary to provide the funding necessary to maintain the current levels of municipal services which are necessary for the health, safety and welfare of the Town of Berthoud and that an emergency exists. The fees set forth in this ordinance shall take effect with the January, 2006 billing cycle.

At its meeting November 28, 2006, a public hearing was set by the Board of Trustees of the Town of Berthoud for its meeting held on the 12<sup>th</sup> day of December, 2006. At the regular meeting of the Board of Trustees, this Ordinance was read, passed and ordered published this 12th day of December, 2006 by a vote of 6 in favor and 1 opposed.
