

RESOLUTION NO. 14-00

A RESOLUTION AUTHORIZING THE TRANSFER OF THE FUNDS FROM THE TOWN OF BERTHOUD'S POLICE OFFICER'S OLD HIRE PENSION FUND.

WHEREAS, the Board of Trustees has determined that there are excess funds in the Town's Police Officers' Old Hire Pension Fund; and,

WHEREAS, the Board of Trustees has determined that funds in excess of those required by Colorado Revised Statutes should be transferred to the funds permitted by Colorado Revised Statutes; and,

WHEREAS, pursuant to §31-30.5-209(3)(a), C.R.S., the Town of Berthoud has published notice for more than 60 days in advance of the public hearing set for August 8, 2000. The Affidavit of Publication being attached to this Resolution; and,


WHEREAS, no persons claiming any right, title or interest to these funds have come forward and no claims have been presented;


NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO THAT:

Pursuant to Colorado Revised Statutes the Town Clerk is authorized to transfer all applicable funds currently in any account or certificate of deposit attributable to the Town of Berthoud's Police Officers' Old Hire Pension Fund into the funds, investments and budgetary accounts permitted by the Colorado Revised Statutes. This transfer is subject to the statutory restrictions and requirements as provided in the Colorado Revised Statutes.

This resolution was passed by a vote of 5 in favor and 1 opposed at the meeting of the Board of Trustees on the 8th day of August, 2000.
