3. Approval of Minutes - Wednesday, February 2, 2022-minutes approved

4. Public Comment

- A. Herb Hergott-Berthoud pickle ball club is requesting 8 or more courts. Wants PORT to consider facilitates to meet the needs if we are using Waggener Park for the location
- B. Support for the location of the pickle ball courts to Waggener. Wants to share approval of having the volleyball courts on the south side of the park, however does not want the courts to have lighting. He also approves the garden aspect of the design.

5. Discussion

- A. Waggener Farm Park Pickleball Courts – Keith Knoll, Public Works Operations Manager
 - i. Preferred layout includes 8 courts (1-ADA compliant court)
 - ii. Some courts have barriers, lighting is included in the design, shared restroom with playgrounds
 - iii. PORT-wants to know if spacing between courts is adequate

- iv. Audience believes a barrier of 4 fencing between courts is necessary to improve the quality of play
- v. PORT suggests a wind barrier on the outer fence
- vi. Audience-consider additional entrance from the east, a walkway in between the north and south courts
- vii. PORT suggests a survey sent out for input from community specific to the current design
- B. Town Park Redesign Update – Keith Knoll, Public Works Operations Manager
 - i. Two designs include volleyball court on either the north or south side of the park
 - ii. PORT recommends the option with the volleyball court closer to the splash park
