4. Public Comment

There was much public comment centered around the rules of Berthoud Reservoir which pertain to non-motorized boating. What is the policy for access to the South boat ramp? Will the reservoir be open at some point in the future? The Committee decided to have a more detailed discussion as an upcoming agenda item. Because of the large amount of discussion, the chat conversations are an addendum at the end of this document.

Other public comments concerned the sidewalk connectivity issues between Heron Lakes and Heron Point near the TPC course.

Representatives from Logan Simpson gave a broad overview of the Open Space Master Plan. Open Space, Natural Areas, Agricultural Preservation, and Trail Corridors were defined.

There was an update on the new Waggener Family conservation easement on HWY 56 between CoRd 3-5. Committee discussed if there were differences between Weld and Larimer Counties. A major difference is that Open Space tax money is for Larimer County only. Outreach with neighbors and other future plans were outlined.

The main points and guidelines were divided into groups:

Conservation: Working Agriculture, L. Thompson & Dry Creek; scenic views, buffers

Water: Water for agriculture, protected drinking water, non-potable water for parks

Trail Corridors: Front Range Trail connectors; Dry Creek to Carter Lake, L. Thompson

Funding: How are developments funded? What are other impacts of the funding?

Community feedback has focused on Bike & Ped, Land Conservation, Tree Canopy

There is a map available on the GIS website for further review.

Member Kurtz asked what is the biggest opportunity. Call responded that it was connectivity and corridors.

Committee was given homework to think about and discuss:

1. Where are your priorities?
2. Why are these your priorities?
3. How would these come to fruition?

The initial response from the committee was the Hwy 56 corridor, access to water, scenic views, and the small town feel.

Staff Member Knoll presented the 2020 PORT Committee Agenda Topics & Report for review.

Farmers need to know that if they cannot sell them when they turn their property over to conservation easement that can effect them generations down the road financially negatively. The Wagners seemed to realize this but Farmers should be well advised of this

- 19:20:28 From Jeremy Call, Logan Simpson : In regards to survey respondents that "Do Not Live In Berthoud": Survey was distributed using postcards to invite local residents to participate. Mailing was sent to 2,934 residents within the Town of Berthoud.

Postcards included a Web address to log into the survey with two passcodes for household members to participate. Additionally, a resident could request a paper survey form by calling a number on the card. About 15 paper surveys were requested and 10 were completed.

Approximately three weeks after the post cards were sent, an "Open" version of the survey was promoted. Residents of the Town, as well as interested individuals living outside Berthoud were encouraged to participate
