3. Approval of Minutes- Wednesday, March 3, 2021 Approved

4. Public Comment

Mr. Charles Tarnutzer brought up a specific comment about the pickle ball courts needing updates for ADA access. The committee suggested to make this a future agenda item, but staff agreed that it should just be addressed since it is an access issue. Mr. Tarnutzer sent a letter detailing his concerns to all PORT members. It is an addendum at the end of these minutes.

5. Discussion

A. K. Kuchar – Open Space Master Plan Updates

The Committee was apprised at updates to the Open Space Master Plan since the last presentation. Ms. Kuchar discussed the Vision of the Plan, which included protecting the agricultural heritage of the area and focusing on conservation of water and natural areas for the entire community.

Member Klein asked what government's role in securing local food sources to help economy. Ms. Kuchar explained that it would/could include access to farmer's markets, educational tours of farmland, et al.

She then discussed the preliminary roles for Berthoud in the process by detailing the types of projects for Berthoud to take the lead and support roles. Finally, she discussed what projects are already happening in the region and how the neighboring communities and districts were involved.

Next, Ms. Kuchar detailed the focus areas of current and future projects on the Berthoud GIS map. The focus areas are 1) Agriculture, 2) Natural Areas, 3) Trail Corridors. These three focus areas were outlined and discussed in detail. Member Kurtz asked how the maps were used. Ms. Kuchar explained that they were used to set priorities which will be brought before the Board and Committees in the future (June for the PORT Committee). Boulder County connections were discussed, as well as the need for more connections in the western open lands and natural areas.

B. C. Kirk & J. Olinger - Trails at Creekview: Mountain View Park

PORT was presented with the various options for amenities to be included in town parks. Mountain View Park will be operated by the town after completion, so the amenities will be available to the town and the neighborhood. A long discussion followed concerning what amenities Berthoud should push for, and what concessions could or should be made in the finalization.

Chair Cabrera praised the requirements for community parks. He also suggested that amenities be based on what other parks and the rec center do not have.

Vice Chair Klein asked if any leeway could be made on enlarging the northern buffer to Hillsdale Park. That section of the development is set.

Member Kurtz asked what incentives there were for developers to create a community park instead of a neighborhood park. No maintenance to the HOA and the town gets a park. He also asked what other parks were in the area and what amenities could be shared or utilized between areas.

C. J. Embrey – Berthoud Reservoir Access

Mr. Embrey updated the committee on watercraft access on the north side of Berthoud Reservoir. He suggested this was the best place to add a launch.

There was a discussion on why the north side when the south side already has a launch. The response was that the south side access is too narrow and would cause congestion. Because of community feedback, this is a priority issue and will provide at least temporary watercraft access in the next 12wks.

D. J. Embrey – Fickel Tree

Mr. Embrey asked for feedback on whether to replace or carve the tree destroyed in the March snowstorm. The committee agreed universally that the tree should be carved.

Liaison Hindman suggest that meeting protocols be set for future meetings, especially for when there is much public comment.
